



NCHIA Rules and Regulations: Proposed Changes

Voted & Approved by NCHIA Board Members on January 5, 2017; For immediate posting to NCHIA members for 30-day comment period

<p>5.7 Members elected as Delegates shall serve a one year term beginning July 1st the year they are elected through June 30th the following year. Delegates shall attend the CHIA House of Delegates meeting in June of the calendar year following their election during their year of service as Delegates.</p>	<p>5.2.D The term of the CHIA delegates elected to represent NCHIA is 1 year. The term will begin with the CHIA House of Delegates occurring in the same year in which the delegates are elected. <i>(Example: Elected January 2017; attend CHIA House of Delegates in June, 2017.)</i></p>
<p>XII. Amendments</p> <p>12.1 The Rules and Regulations of the Association shall be submitted to the CHIA Board of Directors for approval prior to implementation. Changes or revisions shall be submitted to the Chair of the CHIA Bylaws Committee and the CHIA Board of Directors for approval.</p> <p>(Note: If approved current NCHIA rules 12.2 thru 12.7 would be replaced by CHIA CLA template rule 12.2)</p> <p>12.2 Amendments to NCHIA Rules and Regulations may be proposed by any Active member of the Association, the Rules and Regulations Committee, or the Board of Directors. Proposed changes shall be approved by the NCHIA Board of Directors.</p> <p>12.3 Proposed revisions shall be posted on the NCHIA webpage on the CHIA website for a minimum of twenty (20) days. The NCHIA Board of Directors shall provide notice to NCHIA members that the revisions have been posted. The notice may be sent to members by blast e-mail, mail, telephone, voice messaging, facsimile or by other accepted means designed to record and communicate messages.</p> <p>12.4 The notice shall advise members that members may submit approval of or objections to proposed revisions by e-mail to the President or to the Chair of the Rules and Regulations Committee.</p>	<p>12.1 Prior to implementation, Rules and Regulations must be submitted to the CHIA Board of Directors for approval. Any revisions to the CLA Rules and Regulations not consistent with the CHIA Component Local Association Rules & Regulations Template shall be submitted to the CHIA Board of Directors for approval prior to implementation.</p> <p>12.2 Amendments to these Rules and Regulations may be proposed by any Active member of the NCHIA, or by the NCHIA Board of Directors. The NCHIA Board of Directors shall approve all proposed changes to the Rules and Regulations. CLA members shall be given notice of any Board approved changes and shall be given thirty (30) days to comment on the changes. The NCHIA Board of Directors shall review all comments received and shall consider further changes as appropriate. Absent any comments from members the approved changes to the Rules and Regulations shall become effective at the end of the thirty (30) day comment period.</p> <p>12.3 No Change.</p>

Revisions shall be considered ratified 30 days following the end of the 20 day posting period unless substantial objections are raised by the membership.

The NCHIA Board of Directors shall review the responses and consider changes as appropriate.

The NCHIA Board of Directors shall publish the final Rules and Regulations of the Association on the NCHIA webpage of the CHIA website.

These Rules and Regulations shall conform with the provisions governing Component Local Associations as provided for in the CHIA Bylaws and in the CHIA Policy and Procedure Manual.
